Theoretical Basics for the Exam Topics The exam topics are designed in accordance with the framework educational program and the needs of integrative pedagogy. They represent those components of cross-sectional topics that are focused on music education issues.

The topics are based on two principles:

- 1. theoretical-knowledge principle (comprehensive composition analysis, music pedagogy, music psychology, music diagnostics, etc.),
- 2. didactic-creative principle (didactics of music education, thematic and project teaching in music education, etc.).

The topics predict knowledge of specific music theory and music history, (see point ad a), at the same time each name represents a topic for an individually designed didactic unit - lesson (see point ad b)

Required structure of the presentation within the exam. During the exam, the student draws one of the offered thematic areas. The requirement for the exam is an orally annotated presentation containing the concept of lessons according to the relevant topics, with the student within the time set aside for the final state examination in his concept to present in general:

- 1. The requirement for the exam is an orally annotated presentation containing the concept of lessons according to the relevant topics.
- 2. Content: Demonstration of an individually conceived teaching unit according to the phenomena determined by the thematic topic in connection with also an individually selected musical work or works. The work can be presented in the form of a direct interpretation or recording according to its type and according to the intention and possibilities of the student. The choice of material must be substantiated and justified by the psychological and didactic foundations of the music education process listed in each thematic topic.
- 3. Methods and forms of implementation: Description and justification of the activities of teachers and students based on the psychological and didactic foundations of the music education process listed in the relevant thematic topic.

# OSZNM145 Educational science and psychology for teachers The state final pedagogical and psychological examination verifies the basic teacher competencies for the performance of the teaching profession. The student will achieve teacher competencies by completing compulsory subjects. The content of the pedagogical and psychological examination includes two interrelated pedagogy and psychology topics. Individual topics lead to the application of pedagogical and psychological knowledge for teachers in elementary and secondary school. The examination contains a teacher portfolio. The student demonstrates with the teacher portfolio the obligatory pedagogicalpsychological practice and the ability to reflect this practice. During the examination, the student will demonstrate knowledge of the pedagogical and psychological theory and at the same time the ability to apply this theory to specific issues of the teaching profession. Examination topics include teaching and learning, curriculum and curricular documents, planning, work with educational goals, evaluation of learning outcomes, pedagogical and pedagogical-psychological diagnostics, teaching models and teaching strategies, methods and organizational forms of teaching, didactic, pedagogical communication, work with students with special needs, risky behavior of pupils, school and classroom climate, family issues, school counselling services, the legal framework of teacher work, professional development of teachers and coping with difficult situations in the teaching profession.
